Legal and Financial Planning

Addressing Behavior Challenges



Denise Raley Saxman, MSW, LCSW, Care Consultant, Alzheimer's Association, Greater Indiana Chapter, obtained her MSW from Indiana University in 1994 and has worked in the healthcare field since graduation. For the past 9 years, she has worked for the Alzheimer's Association, Greater Indiana Chapter where she is one of four care consultants. In this role, she meets with families and persons with dementia to help them address the challenges dementia can present. Services include education about the disease, care planning, referrals to community resources and links to other chapter services. She also manages and supports approximately 65 volunteer Support Group Facilitators. Her previous work experience includes 10 years as a home hospice social worker in Maryland and a HIV/Aids social worker at Wishard Health Services (now Eskenazi Health) in Indianapolis.

Kate Kunk, RN, CIRS-A/D, coaches family caregivers throughout Central Indiana on behalf of CICOA Aging & In-Home Solutions. Kate holds degrees in Nursing and Sociology as well as certificates in Gerontology and Faith Community Nursing. She is also certified as a Dementia Caregiver Coach by the Rosalynn Carter Institute for Caregiving at Georgia Southwestern State University. Before joining CICOA, her advocacy and case management skills took her from homeless shelters in New York City's Hell's Kitchen and Virginia's Roanoke Valley to a psychiatric clinic in Tennessee's Great Smoky Mountains. Kate has also worked extensively in the publishing industry, during which time she developed educational materials for McGraw-Hill and Pearson in the New York Metropolitan area. Improving the quality of life for people of all ages is one of Kate's lifelong passions.

End-of-life Planning and Care



Susan Hickman, PhD, is a geropsychologist, Professor at the Indiana University School of Nursing, and a Co-Director of the RESPECT (Research in Palliative and End-of-life Communication and Training) Center at IUPUI. She has been educating and conducting research on advance care planning for over 20 years. Dr. Hickman is currently funded by the National Institutes of Nursing Research and the Retirement Research Foundation to evaluate the quality of advance care planning decisions in the nursing facility setting. She is also Co-Principal Investigator on a National Institute on Aging funded pragmatic randomized clinical trial to evaluate an ACP Specialist Program for people with Alzheimer's disease and related dementias who live in nursing homes.
